

We are aware of how profound the transformation in our communities has been so far in 2020: the impact of the pandemic, how it has not only threatened our health and safety, but laid bare disparities so present for our Black, Indigenous, and People of Color (BIPOC) neighbors.

Our community experienced another killing of a Black man at the hands of police. George Floyd's face is the face of our communities. He is our resident, he is our student, he is our staff, he is our banking class graduate, our proud emerging leader brimming with promise and hope. And he was taken from us.

These are challenging times, particularly for those with limited resources and few opportunities. With your support, PPL has stayed firmly committed to our vision of creating hope, assets, and self-reliance for individuals and families in our community with lower incomes. We are steadfast in our mission and constantly reminded to not lose sight of our true, shared objectives, even on the most challenging days.

Thanks to the results you made possible in 2019, PPL is well-positioned to act with urgency and innovation in 2020:



**70 units of affordable housing were built or upgraded across the Twin Cities**, including opening Mino Oski Ain Dah Yung that serves Native American youth experiencing homelessness, another example of PPL's deep cultural partnerships. PPL was also selected to develop 380 units of affordable housing on the historic Ford site in St. Paul over the next decade. Construction on the first building begins in 2021.



**Our Career Training graduates increased their income by 4x on average**, a record high for PPL. We continue to provide training across a broad spectrum, from ensuring youth graduate from high school employment-ready to coaching jobseekers to take the next step in their career. We also celebrated the 50th graduation in our financial services training program, and saw 58 young adults graduate from our alternative high schools.



We helped conduct research that asked if a criminal background impacts a resident's housing success, and **used the data to advocate for housing requirements that don't perpetuate disparities**. We also partnered with community organizations to elevate the voices and rich history of the Phillips neighborhood that PPL has been a part of for nearly 50 years, by creating a 4,000 sq. ft. mural on the side of PPL's newly completed Career Center.

**Nearly 13,000 individuals and families with lower incomes were served in 2019, and thanks to you, that number continues to grow.**

PPL's model of stabilizing the economics of a household through affordable housing and career training is more relevant than ever. Thanks to you, our work hasn't missed a beat.

PPL served 84% BIPOC (Black, Indigenous, People of Color) and 90% people living in poverty, which helped reduce racial and economic disparities.


